This is the internet privacy and cookie policy for 12 Old Square Chambers website.

The information you voluntarily provide us through this site (which may include your name, company, address and contact details such as your telephone number, email address or fax number) will be used for the purposes of satisfying your requests, such as publications or recruitment processes and event organisations. If you have emailed us with an enquiry (for example, in relation to a press release or forthcoming seminar or other event) we will use your email address to respond to your query. We may also send you further information about our services or keep you informed of legal updates through our periodic newsletters, provided you have indicated that you are happy to be contacted for these purposes. We will always ask your consent for such communication.

If you choose to separately to complete the 'Contact Us form', we may collect information relating to the enquiry and details.

You can tell us not to contact you with updates and information regarding our products and services either at the point such information is collected. You can also exercise this right at any time by contacting us using the contact details at the end of this internet privacy policy.

With whom is the information shared?

We may disclose your personal information to our agents or contractors who assist us in providing the services we offer, such for example in fulfilling requests for information, receiving and sending communications, updating marketing lists, analysing data, providing support services or in other tasks from time to time. Our agents and contractors will only use your information to the extent necessary to perform their functions.

We may disclose personal information if required to do so by law, Court order or for the purposes of prevention of fraud or other crime or if we believe that such action is necessary to protect and defend the rights, property or personal safety of 12 Old Square Chambers, the 12 Old Square Chambers website or its visitors.

International transfers

Information that you submit via the site may be transferred to countries outside the European Economic Area (“EEA”). By way of example, this may happen if one or more of our servers are from time to time located in a country outside the EEA or one of our service providers is located in a country outside the EEA. If you make contact with any business featured on the site your details may be transferred outside the EEA. If we transfer your information outside the EEA in this way, we will take steps to ensure that your privacy rights continue to be protected.

Use of cookies by 12 Old Square Chambers

The EU e-privacy Directive 2009 (the “Directive”)

Under the Directive which amended the Privacy and Electronic Communications Regulations 2003 we can store cookies on your computer if they are essential to the operation of this site but for all other “non-essential” cookies we need your permission to do so.

Cookies

Cookies are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently to improve the user experience, as well as to provide certain information to the owners of the site. 12 Old Square website sets cookies which remain on your computer for differing times. Some expire at the end of each session and some remain for longer so that when you return to our website, you will have a better user experience.

Cookies allow us to update the count of how often a page is shared when a user forwards or shares one of our web pages on social media sites or with another user. We use cookies to personalise content we send to you and to make our marketing more relevant.

Cookie Consent

Web browsers allow you to exercise some control of cookies through the browser settings. Most browsers enable you to block cookies or to block cookies from particular sites. Browsers can also help you to delete cookies when you close your browser. You should note however, that this may mean that any opt-outs or preferences you set on the site will be lost.
